Over the years, the GNLU LSC strived to recognize law as an instrument of social change. The Committee leads a wide range of activities from pro-bono and legal aid clinics to piloting research projects to piloting multiple drives, including one-of-its-kind Prison Legal Aid Clinic.



GNLU Annual Legal Services Forum (GALSF)

The GNLU Annual Legal Services Forum (GALSF) is the flagship initiative of the GNLU Legal Services Committee, designed to unite Legal Aid and Services Committees across India, promote collaboration, and address key socio-legal challenges. It provides a national platform for universities, NGOs, Legal Services Authorities, and experts to share experiences and advance accessible, affordable legal services for underserved communities

Across six editions, GALSF has grown into a leading forum for legal aid institutions, scholars, practitioners, and students to strengthen India's legal aid framework. The 7th edition builds on this legacy by examining how Al-driven tools can democratise legal knowledge, reduce delays, enhance legal aid mechanisms, and mitigate structural barriers to justice. For the first time, it will be held as a weeklong Legal Services Week, offering a range of academic, experiential, and community-focused activities.

Mediation Competition

The Mediation Competition is a central feature of the 7th GNLU Annual Legal Services Forum, aimed at equipping participants with practical dispute-resolution skills essential for strengthening access to justice in an evolving legal environment. In line with this year's theme, it weaves in contemporary discussions on how technology can support and enhance mediation across varied legal contexts.

It provides law students with a platform to engage with realistic, socially grounded disputes in family law, consumer issues, labour relations, technology conflicts, and everyday rights-based grievances. Through structured sessions, students act as client-counsel teams and mediators, gaining hands-on experience in negotiation, communication, problem-solving, and interest-based settlement.

Participants are encouraged to explore the role of Al-enabled tools, such as online mediation platforms, digital evidence systems, and automated scheduling in streamlining mediation and expanding access for underserved communities. Overall, the Competition offers a dynamic learning environment that nurtures empathetic, innovative, and solution-oriented professionals committed to a more efficient and inclusive justice delivery system.

Team Composition

Each university shall have one team with three members — One Mediator and a pair of Client Counsel.

All three members of the participating team must be from the same institution.

Eligibility and Representation

- Any College/University/Institution in India can participate in the Mediation Competition.
- Each Participant must be a current Undergraduate Student (5-year or 3-year Law Course) of their respective institution.
- Each participating College/ University/Institution must send one team comprising of three members.

Paper Presentation Competition is a pioneering cornerstone of the 7th GNLU Annual Legal Services Forum, reflecting the Forum's fostering research-driven commitment to advocacy and informed socio-legal engagement. Anchored in this year's theme: the competition encourages the Legal Aid Cells and Legal Services Committees of law universities and college to critically and analyse participate technological advancements are reshaping the justice delivery system.

This edition places particular emphasis on empirical research, prompting the participating LACs and LSCs to assess the real-world impact of Al-enabled tools on legal accessibility, procedural efficiency, digital literacy, and the functioning of legal aid mechanisms. Through field surveys, stakeholder interactions, and data-backed evaluation, researchers are expected to examine opportunities and challenges associated with Alin legal support systems alternative dispute

Participants will present their findings before an expert panel, articulating evidence-based insights and proposing innovative, practical recommendations for strengthening India's technology-driven justice framework. The competition thus serves as a platform for young scholars to contribute meaningfully to contemporary legal discourse while cultivating analytical, presentation, and policy-oriented skills.
